

As a person residing in Canada you can exercise the following rights:

- right to physical safety
- right to access emergency, legal and support services
- right to a violence free personal life
- right to protect your child(ren) from violence
- right to receive service in either French or English (an attempt will be made to provide service in your mother tongue)

Domestic Violence in Canada:

In Canada, it is illegal to physically or sexually abuse one's intimate partner, whether it is a spouse, common-law partner, a girlfriend or boyfriend. It is also illegal to use threats of violence or intimidation to maintain control in a relationship.

As a member of the diplomatic community, you can seek protection from violence in your relationship through the local police service.

The following information is designed to help you make informed choices in your life and in the lives of your children.

If you are experiencing domestic violence, every effort will be made to provide you with appropriate service.

Ottawa Police Service: (OPS)

- if possible, wait for the police outside your home, particularly if you reside at an Embassy
- OPS has a specialized Partner Assault Unit which will investigate your situation
- OPS will refer you to their Victim Crisis Unit

- will provide crisis intervention, support and referral to victims of crime and tragic circumstances

- will coordinate between all agencies to ensure that your privileges and rights, under the Vienna Conventions, are respected and up-held

- will, as per agreement with the OPS, participate in an assessment of your situation, particularly if there are further concerns for your safety
- if possible, wait for the police outside your home, particularly if you reside at an Embassy
- will assist you in accessing other community resources

- if your situation involves children/youth

(under the age of 16) and you are concerned about the impact of violence on their lives, the CAS will be able to assist with support and further follow-up

- if during the course of a violent episode with your partner your children/youth are at risk of physical/emotional harm the CAS will assess the level of risk or any further safety concerns

- if you are a victim of domestic violence and you are seeking legal advice regarding family law issues such as custody, visitation rights or restraining orders, the FLO can assist you to obtain the necessary information
- the FLO will assist you in applying for legal aid (free legal service) and in accessing other community resources
